Purpose of report

1. The purpose of this Committee Report (CR) is to consider and approve the draft Public Services Reform Act 2010 – "definition of public relations" Internal Guidance Note.

Executive summary

- 3. Section 31 of the Public Services Reform (Scotland) Act 2010 (PSRA) requires public bodies to publish information on "certain expenditure" each year. In preparing reports to publish on this expenditure for the Scottish Information Commissioner (the Commissioner), data is gathered from a range of sources, including a monthly monitor log of activity falling within the category of "public relations", as listed in the PSRA.
- 4. The key document 'Public Services Reform Act 2010 "definition of public relations" Internal Guidance Note' is used to provide clarification for the Commissioner's staff on what activity should be classed as "public relations" and recorded for the purposes of the log.
- 5. The document has been reviewed and the following changes proposed:
 - (i) reference to the decisions round up (DRU) for external publication has been changed to refer to decision learning points for the email newsletter, since the decisions round up is no longer shared externally other than as part of the email newsletter
 - (ii) reference to preparing and editing the DRU has been specified as for internal use.
